Our Venue: Curtin Stadium



Curtin Stadium is in a prime position on the campus of WA's largest University, hosting over 57,000 students and leading academics. The venue is 10 km from Perth CBD with public transport to the door and parking in the proximity of the stadium.

The indoor carpeted arena hosts up to 2450 people with a further 1000 people in the adjoining outdoor undercroft and is fully wheelchair accessible. The Stadium also has a separate presentation space, audiovisual displays, café, and bathroom facilities and is flanked by immaculately maintained, open grassed areas.

Multiple double-door entry points, ramps, and drive-through capabilities to the undercroft will provide vendors and exhibitors easy access to the indoor exhibition space, with undercroft staging also available for displays of significant size and weight.

Professional security will be provided overnight, allowing displays to remain intact throughout the show.

The PGMS committee is excited to bring like-minded communities and individuals together for this annual event, with Curtin Stadium providing plenty of room to host.



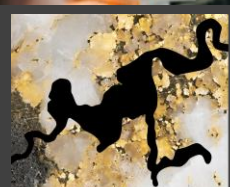

Terms and Conditions

Returning a completed Application Form confirms your acceptance of the following terms and conditions:

All bookings are subject to approval by the PGMS Committee, and we reserve the right to refuse an application.

PGMS and the Show Organisers reserve the right to alter any aspect of the program and floor plan without prior notice. All event details will be sent to you via email at appropriate times.

PGMS and the Show Organisers will take all diligent care to fulfill the above vendor and exhibitor commitments. Vendors and exhibitors are responsible for providing their requirements i.e., banners, promotional material, and any other material by the due dates requested by the Organisers.

PGMS and the Show Organisers reserve the right to introduce new packages and additional exhibition space should the opportunity and/or need to arise.

Vendors and Exhibitors are required to make the necessary payments as per the payment schedule below (unless otherwise negotiated):

- 50% due within one month of the invoice date
- Remaining 50% due no later than 14 days before event (e.g., 30/09/22)

Vendors and Exhibitors are responsible for the security of their own equipment and materials during the day of the event and in transit to/from the event venue. On-site professional security will be provided overnight on the Friday and Saturday nights.

The Vendor/Exhibitor understands that all delegate attendees must register officially and entry to the exhibition will not occur unless the attendee has the appropriate identification.

The Vendor/Exhibitor guarantees that their stand will be open for the full duration of the show.

Electricity will be provided to each trade stand, but stand holders are required to provide their own lights and extension leads. All leads and lights must be in "safe working order" and may be removed if not in said order. Additional leads over floors are NOT allowed under any circumstances.

No individual indoor display and/or sale pieces will exceed 400kg. Larger material can be displayed in the outdoor undercroft on request.

All material for sale should be correctly labelled. Treated stones and synthetic, simulant material, or lab-created material are required to be labelled as such.

In the event of a dispute between a trade stall holder and a purchaser over the authenticity or accuracy of labelled materials, a full refund will be made by the seller to the purchaser.

Where material is identified, by a qualified person, as being incorrectly labelled or described, the material will be removed from sale until correctly described. Failure to remove incorrectly identified material will result in the trade stand holder being removed from the event.

The Vendor/Exhibitor shall take all reasonable care when installing/dismantling their equipment and trade stand so as not to cause damage to the venue carpet, walls, ceilings, fixtures, and floors and the shell scheme booths supplied by the appointed stand contractor including panels, fascia, and furniture. The Exhibitor is deemed liable for repairs if the structures are damaged.

The Organisers reserve the right to request removal of any items that may be deemed inappropriate and/or impacts fellow Exhibitors.

Any products which display false or misleading information/claims will not be allowed at the show (refer to the Australian Competition & Consumer Commission – ACCC rulings).

All promotion must be conducted from your trade stand unless otherwise arranged with the Organiser.

All Vendors/Exhibitors are expected to conduct their business in a professional, ethical manner and follow the instructions of any PGMS member. Any breach may result in immediate cancellation of the Vendor/Exhibitor package.

If a Vendor/Exhibitor is found to not align their values with those of the PGMS, this may result in the cancellation of your Vendor/Exhibition package.

Vendors with 3 or more tables will be required to submit their desired floor layout.

LIABILITIES AND INSURANCE

It is a requirement by Curtin Stadium for every trade stand to be covered by Public Liability Insurance (PLI). Failure to provide proof of PLI before the application cut-off date will result in the cancellation of the Vendor/Exhibitor package.

PGMS and MinSoc WA are not and shall not be liable for any lost, stolen, or damaged goods.

The Vendor/Exhibitor indemnifies the Committee and Show Organisers and any representative, employee, contractor, volunteer, or officeholder from and against any claim, demand, action, loss, cost, damage, or expense whatsoever.

The Vendor/Exhibitor will be responsible for any damage or injury to property and/or persons which may be occasioned by, or caused by, or arising out of the use of any machinery, implements, or apparatus whatsoever used in conjunction with their trade stand, and indemnifies the PGMS Committee accordingly by acceptance of these Terms and Conditions.

CANCELLATION POLICY

The submission of an application by a representative from your organization is regarded as a firm booking.

All cancellations must be made in writing to the Organisers and notice acknowledged in writing by the Organisers.

Any reduction in a Vendor and/or Exhibition allocation (once accepted by the Organisers) will be considered a cancellation and the cancellation policy will apply.

Should the balance payment be outstanding at the time of cancellation, the Vendor/Exhibitor is liable for the balance as per the cancellation policy.

There is no opportunity to transfer your Vendor/Exhibition booking to another PGMS event.

CANCELLATION DATE

Up to and including 14 days before the event: full refund.

13 days or less before the event: 100% cancellation fee and will be liable for payment of the balance should it not have been received by the cancellation date.

COVID-19 POLICY

In the event of a Government-mandated cancellation due to an outbreak of COVID-19, either a full refund will be issued, or the balance of the vendor/exhibitor fee rolled over until the next event should that event occur within 12 months of the original Event date. In the case of rolled-over funds and the Event does not proceed within 12 months, a full refund will be issued.

Extra cleaning and/or physical distancing measures may be required at the time of the event, depending on Government and Venue requirements.
